

The sale against this tender shall be governed by the Terms & Condition set out in Annexure-“A” and the Bid form in Annexure- “B” to this Notice. Persons interested in purchasing the above mentioned condemned department vehicle may inspect said vehicle at the above mentioned place on any working day upto 25.03.2019 between 10:00 A.M to 05:00 PM and any enquiry / details regarding the tender can be obtained from the Superintendent, Divisional Preventive, O/o Assistant Commissioner of Customs, Customs Division, Nagapattinam.

The interested parties/Individuals are to submit their bids in the prescribed format as annexed to this notice (Annexure-B) along with **Earnest Money Deposit of Rs 5000/- (Five Thousand only)** by way of Demand Draft in favour of "The Assistant Commissioner of Customs, Customs Division, Nagapattinam.

Last date for submission of tender is 25.03.2019 up to 05:00 PM. The sealed tenders will be opened on 26.03.2019 at 11:00 A.M in the presence of bidders.



TERMS & CONDITIONS

1. The sealed bid shall be **received by this office up to 5:00 PM on 25.03.2019** Any bid received after the prescribed deadline shall not be considered. Tender should be addressed to "The Assistant Commissioner of Customs, Customs Division, Nagapattinam".
2. The bids shall remain valid for a period of 2 months from the date of receipt of the bid.
3. The rates quoted by the bidders for purchase of old condemned department vehicles will be all inclusive and on "As is where is basis". Any statutory or other charges shall be borne by the bidder. The successful bidder will take possession of the vehicles on a date and time specified by this office and will arrange for transportation of the same on that day at his expense.
4. The vehicles will be disposed off on the basis of highest rate. However, this office reserves the right to withdraw the vehicles from the bidding process in case the quoted price received is less than the reasonable market price.
5. The successful bidder must adhere to the time limit. Failure to deposit the requisite sum before the stipulated date/ time entails the forfeiture of the contract as well as Earnest Money. After delivery of the vehicle, this office will not be responsible for any damages to the vehicle or person
6. This office reserves the right to annul the bidding process at any time prior to award of contract including rejection of any or all bids after the same have been received, without thereby incurring any liability to the affected bidder/s or any obligation to inform the affected bidders on the ground of this office's action
7. The bidders may physically visit and inspect the Vehicle before putting in their bid. The Superintendent, Preventive Unit, Custom Division Nagapattinam may be contacted for inspection of the vehicle. **The inspection of the vehicle may be done from 10:00 AM to 05:00 PM of any working day up to 25/03/2019.** No complaint whatsoever will be entertained after closing of tender. No request for inspection after submission of tender will be accepted.
8. The vehicle shall be handed over to the successful bidder against 100% deposit of offer/ bid value.
9. The payment will be accepted by this office in the form of **Demand Draft of a nationalized bank** only. The payment has to be submitted by the successful bidder within 7 days of the date of delivery of the order otherwise the offer will be cancelled and earnest money shall be forfeited.
10. Disputes, if any, shall be subject to jurisdiction in the Court of Nagapattinam only.
11. Tendering form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
12. Once the release order issued, this office will not be responsible either for safe

custody or for any loss or damage to the subject vehicle.

13. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.
14. The sealed tenders super scribed "**Tender for sale of condemned office vehicle**" will be opened **on 26/03/2019 at 11:00 A.M** in the presence of bidders, if any.
15. The scheduled day for opening the sealed tenders, if declared to be holiday due to any unforeseen reasons, the same will be opened the next immediate working day.
16. The bidders should quote the amount for purchase of the subject vehicle both in words and in figures, if there is any difference between the amounts mentioned in figures and that of in words, the rate quoted in words will be taken in to account and accepted on record.
17. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number
18. The person authorized by bidder will be allowed to take the delivery. The bidder is required to produce any of documents as documentary evidence for proof of their address.(Ration Card /Voters Identity Card in case of individual and Registration Certificate in case of firms etc.)
19. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
20. The vehicle will be delivered only after the receipt of full payment and has to be lifted at their own expenses within 07 days of completion of deal. Permission to take out the disposed vehicle from above mentioned locations will not be allowed on holidays, Saturdays and Sundays etc.
