**PUBLIC NOTICE No. 27/2025**

Subject: Customs – Re-constitution of Permanent Trade Facilitation Committee (PTFC) at Tiruchirappalli Customs Commissionerate – Reg.

The Central Board of Indirect Taxes and Customs (CBIC) has implemented wide-ranging reforms focusing on digitization, transparency, and trade facilitation. Within this context, Permanent Trade Facilitation Committee (PTFC) established under Circular 42/2013-Customs dated 25.10.2013 has played a pivotal role in stakeholder engagement and resolving trade grievances. In this regard, the Board has now issued a Master Circular No. 21/2025 dated 12.09.2025 which consolidates and supersedes earlier guidelines to realign this committee besides taking measures keeping in view current priorities of consultative decision- making, stakeholders' engagement and grievance redressal, and integration with national trade facilitation objectives.

2. The PTFC shall meet fortnightly as per the schedule given in Table-A.

Any changes in the above schedule will be intimated through email. It is to note that agenda points received on or before the cut-off dates alone will be taken up for discussion in the respective PTFC meeting. Agenda points received after the cut-off dates will be taken up in the subsequent PTFC meeting.

3. The Composition and Terms of Reference (ToR) for Permanent Trade Facilitation Committee (PTFC) has been revised in line with Circular No. 21/2025 dated 12.09.2025 as follows:

**(a) Composition:**

The PTFC shall be constituted at each Customs Station. The jurisdiction of Trichy Customs Commissionerate consists of several multiple minor ports, CFS, ICDs, Airports and ACCs spread across a vast jurisdiction. Hence, it has been decided to constitute a common PTFC in respect of all the minor ports, ACCs, Airports, ICDs & CFS falling under the jurisdiction of Tiruchirappalli Commissionerate. The jurisdictional Pr. Commissioner or Commissioner of Customs, as the case may be, shall chair the meeting accompanied by all senior departmental officers. The Committee, in addition to senior Customs officers, shall include representatives from DGFT, custodians, PGAs, shipping lines, logistics service providers, trade councils, and Customs Brokers, besides existing trade participants.

**(b) Terms of Reference (ToR) for the Permanent Trade Facilitation Committee (PTFC) are as follows :**

(i) Ensuring and monitoring expeditious clearance of imported and export goods in accordance with the timeline specified by the parent Ministry/ Department concerned.

(ii) Identifying and removing bottlenecks, if any, for streamlining and easing the Customs clearance process of imported or export goods. Issues/concerns raised by trade/ Importers or Exporters during a month through grievances should also be included in the Agenda items for discussion in PTFC meeting.

(iii) Resolving grievances of importers, exporters represented by trade bodies and industry and flagging the issues having pan India implication or that may not be resolved at local level to jurisdictional Chief Commissioners, as required.

(iv) Establishing Single point of Contact (SPOC) and circulating its details across all agencies for effective coordination and collaboration for faster clearance process.

(v) Reviewing routinely the membership of the PTFC with the aim of including all stakeholders in the Customs functioning.

(vi) Proper implementation and effective monitoring of existing grievance redressal mechanisms (TSKs, AEM or ICEGATE Helpdesk etc) and to escalate unresolved issues to NACs.

(vii) Outreach to trade regarding new trade facilitative EoDB measures.

(viii) Ensure timely resolution of grievances and bottlenecks

(xi) Escalate unresolved issues to NACs.

(x) Uploading a list of all TSKs, along with contact officer's E-mail IDs. Accordingly, a consolidated list of all TSK (Turant Suvidha Kendra) established under the jurisdiction of Trichy Customs (P) Commissionerate is given below:
