Sub: Conduct of Additional CBLR Regulation 6 (F-Category) Exam 2025 —reg.

With the approval of the Competent Authority and in accordance with Regulation 6 of the Customs Brokers Licensing Regulations (CBLR), 2018 (as amended), it is hereby notified that the **Additional CBLR Regulation 6 (F-Category) Exam, 2025**, as a special measure shall be conducted by NACIN on **16.12.2025** at designated examination centres across India.

2. All candidates who were shortlisted for the CBLR Examination, 2025 (whether they actually appeared in the written examination or not) shall only be eligible to appear in the additional examination. The pool of candidates shall remain confined to those already registered for CBLR Examination, 2025 only. No fresh applications will be invited, and candidates who have already been selected in the final results of the CBLR Examination, 2025, shall retain their selection and are not required to appear again.

3. There is no issuance of a fresh advertisement/notification inviting new applications.

4. For the purposes of Regulation 6(4) of the CBLR, 2018, the CBLR Examination, 2025 and the additional examination, 2025 shall together be treated as a single attempt.

5. The written examination will be a Computer-Based Examination (CBT) of 2½ hours (10:30 hrs to 13:00 hrs) with 150 Multiple Choice Questions (MCQs). Questions will be bilingual in English and Hindi.

6. Examination pattern:

7. The syllabus shall remain the same as prescribed under Regulation 6(7) of the CBLR, 2018. Candidates qualifying the written examination shall be required to appear for the oral examination. Successful candidates will be called for an oral examination for which separate communication will be sent. The oral examination will be held during the calendar year 2025. **The pass percentage marks for qualifying in the oral examination will be 60%.**

8. Admit Cards will be made available well before the examination date on www.nacin.gov.in under Examination → Customs Broker → Practice Test. Candidates will also be informed by email. A dummy test paper will also be hosted on the same portal.
