The change of name will not wither/take away the responsibility cast upon the CFS Custodian to clear litigations, Tax disputes, Show Cause Notices, arrears pendency, if any, in the name of M/s ALS Tuticorin Terminal Private Limited, Tuticorin. It is further reiterated that M/s DahNAY Tuticorin Terminal Private Limited, Tuticorin, as a Custodian/CCSP will own up to and honour the liabilities, prior to the name change, noticed if any in future,

against the violations/acts of past period, as well as liabilities/issues which are currently pending, and also all future liabilities, that may arise against M/s ALS Tuticorin Terminal Private Limited, Tuticorin.
